Under the cafeteria approach to Health Care Services AYUSH dispensaries are opened in existing and upcoming hospital/dispensaries running under Delhi Health Services for ease of patients and to promote cross-referral.

Directorate of AYUSH is headed by Director (AYUSH) and is assisted by administrative officers and technical officers viz. Deputy Director, Assistant Director, Licensing Authority of Ayurveda and Unani drugs.

Vision:

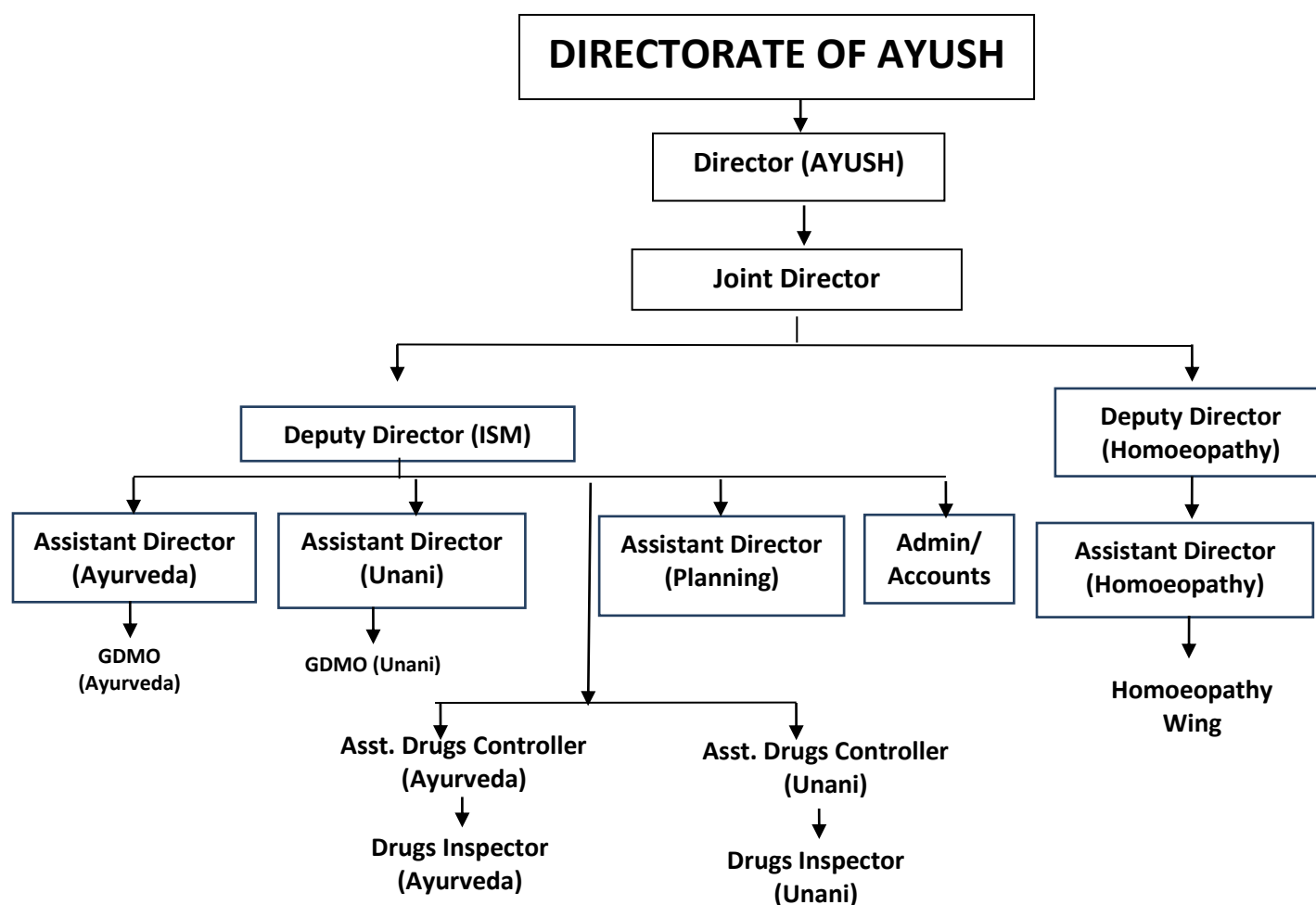
To strive to be treatment of choice for communities by educating and enabling access of AYUSH treatment for acute as well as chronic diseases
